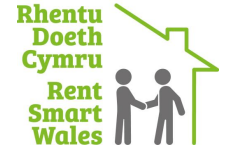

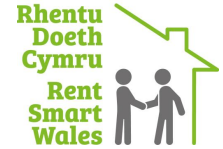
Mailshots

Engagement has consequently increased. Average open rate of 47% across all mailshots.

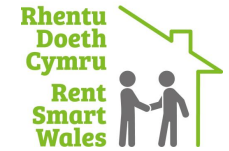

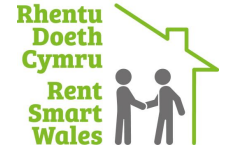

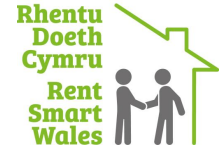

Landlord and agent Licensing requirements in Wales

In Wales, landlords and agents who undertake letting and management work at rental properties are legally required to have a Rent Smart Wales licence.

The Housing (Wales) Act 2014 requirements aim to ensure that those letting and managing domestic tenancies are suitable to do so and are appropriately trained in their rights and obligations.

What letting and management activities trigger the need for a licence?

A landlord who doesn't employ an agent needs to be licensed.

An agent will require a licence if they are **collecting rent** or acting upon instruction from a landlord or a tenant to undertake **more than one** of the following activities.

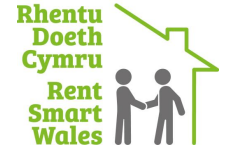

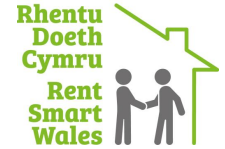

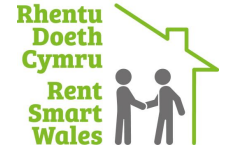

- First licence expires 04.01.2021
- 774 licence renewal applications due before end of March 2021
- Majority are landlords
- System simplified - often confirmation only

- Correspondence and application forms redesigned



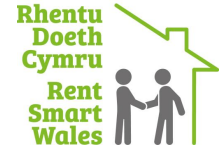

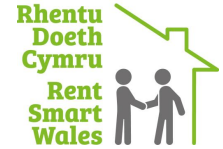

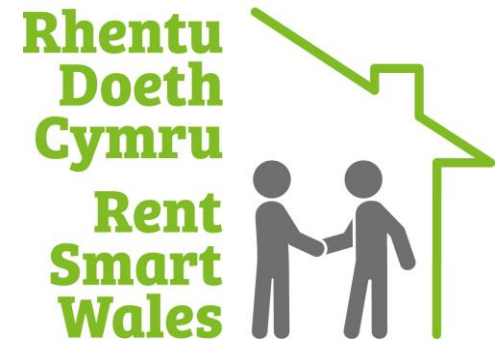
